### How to use:

#### 1. Check compatibility

Ensure that one of the devices has a USB-A port (e.g., charger, power bank), and the other has a Micro USB port.

#### 2. Connecting

Insert the USB-A end into the power source.

Connect the other end (Micro USB) to the device (e.g., smartphone, tablet, console).

### 3. Power supply and data transfer

- Charging: Charging will start automatically.
- Data transfer: Supports synchronisation with computers via USB 2.0.

### 4. Disconnecting

Always disconnect the cable by holding the connector – never pull on the cable.

### Safety warnings

- Avoid contact with water – risk of electric shock.
- Do not store the cable in places exposed to high temperatures.
- Do not modify the cable – this may void the warranty.
- Do not use the cable with damaged connectors.
- Keep away from children – possible risk of swallowing or electric shock.
- Do not overload the cable – use it according to the specifications.
- Disconnect the cable when not in use.

### Maintenance and storage

- Store the cable in a dry and cool place.
- Avoid excessive bending or twisting of the cable.
- Regularly check the cable for damage.

### Warranty

Improper use or incorrect placement of this product by users may result in reduced lifespan or damage, and any resulting damage is not covered by the warranty or does not exempt the manufacturer from liability. The warranty covers manufacturing defects and material faults. The manufacturer's warranty is 24 months.
