### How to use:

#### 1. Check compatibility

Ensure that one of the devices has a USB-C port and the other has a Lightning port (e.g. iPhone, iPad, AirPods).

#### 2. Connecting

Insert the USB-C end into a charger, laptop, or other power source.

Connect the other end (Lightning) to the Apple device.

#### 3. Power and data transfer

- Charging: Using the appropriate USB-C charger, the device will start fast charging (up to 20W).
- Data transfer: The cable supports file synchronisation with computers equipped with a USB-C port.

#### 4. Disconnecting

Always disconnect the cable by holding the connector – never by the wire.

### Safety warnings:

- Avoid contact with water – risk of electric shock.
- Do not store the cable in places exposed to high temperatures.
- Do not modify the cable – this may void the warranty.
- Do not use the cable with damaged connectors.
- Keep away from children – potential risk of swallowing or electric shock.
- Do not overload the cable – use it according to its specifications.
- Disconnect the cable when not in use.

### Maintenance and storage

- Store the cable in a dry and cool place.
- Avoid excessive bending or twisting of the wire.
- Regularly check the condition of the cable for damage.

### Warranty

Improper use or incorrect placement of this product by users may result in shortened lifespan or damage, and any resulting damages are not covered by warranty or exempt from the manufacturer's liability. The warranty covers manufacturing defects and material defects. The manufacturer's warranty is 24 months.
