How to use:

1. Check compatibility

2. Connecting

Select the appropriate port (USB-A or USB-C) and connect it to the power source (charger, power bank, computer).

Connect the chosen end (USB-C or Lightning) to the device you wish to charge.

3. Power and data transfer

- Charging: The cable will automatically adjust the charging power according to the device and source.
- Data transfer: Data transfer occurs according to the USB 2.0 standard, enabling synchronisation and file transfers.

4. Disconnecting

Always disconnect the cable by holding the tip – never the wire.

Safety warnings

- Avoid contact with water – risk of electric shock.
- Do not store the cable in places exposed to high temperatures.
- Do not modify the cable – this may void the warranty.
- Do not use the cable with damaged ends.
- Keep out of reach of children – risk of swallowing or electric shock.
- Do not overload the cable – use it within its parameters.
- Disconnect the cable when not in use.

Maintenance and storage

- Store the cable in a dry and cool place.

- Avoid excessive bending or twisting of the wire.
- Regularly check the condition of the cable for damage.

Warranty

Improper use or incorrect placement of this product by users may result in a shortened lifespan or damage, and any resulting damage is not covered by warranty or is subject to the manufacturer's liability. The warranty covers manufacturing defects and material faults. The manufacturer's warranty is 24 months.
